Shares of Stock

Giving appreciated assets like stocks can provide a charitable deduction and capital gains tax savings.

Donor-Advised Fund (DAF)

You can direct current grants from your donor-advised fund to support Children's Hospital Colorado.

Qualified Charitable Distribution (QCD) from your IRA

If you are age 70 ½ or older, you can transfer funds directly from your IRA to Children's Colorado. This type of gift (up to \$108,000 annually) typically avoids additional income tax and counts toward your annual required minimum distribution.

Real Estate, Artwork and other Non-Cash Assets

You can donate these items as well as business interests and other non-cash assets to Children's Hospital Colorado Foundation. This allows you to make a meaningful impact while potentially minimizing capital gains taxes.

Will or Trust

Including Children's Hospital Colorado Foundation in your will or revocable trust is an easy way to support kids without any cost during your lifetime.

You can designate a specific amount or a percentage of your estate, ensuring both your loved ones and organizations you care about are provided for. And you may change your gift intention at any time.

Beneficiary Designation

Naming Children's Hospital Colorado Foundation as a beneficiary of **retirement accounts, life insurance policies, donor-advised funds** or **financial accounts** is a simple way to make a lasting impact. This option can offer both income and estate tax advantages, helping you support children's health while preserving your other assets for loved ones.

You don't need to update your will — just complete a beneficiary designation form with your plan administrator.

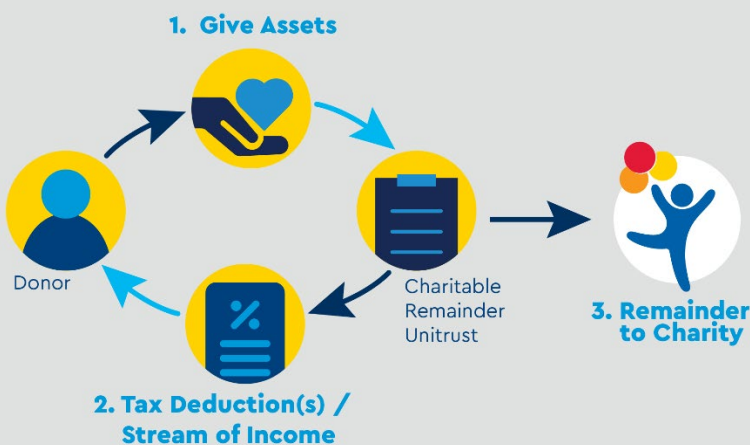
GIFTS THAT PAY YOU BACK

Life Income Gifts, including charitable remainder trusts, allow you to support Children's Colorado while providing income for yourself or a loved one. These gifts offer immediate tax benefits, lifetime payments and may reduce capital gains taxes if funded with appreciated assets.

Charitable Remainder Trusts* convert appreciated assets into a steady income stream for a set term or life while also benefiting our mission.

You receive a charitable deduction when creating the trust and designated payouts for life or the trust's term. When the trust ends, the remaining balance supports Children's Colorado and the future of pediatric care.

This giving option offers income security for you and valuable support for our young patients, with potential tax advantages on capital gains and estate taxes — making it a win-win for you and the children we serve.



*Trusts are simple estate planning devices in concept, but they can be complex because of the many technical drafting requirements of the IRS. Our team is here to help, but we also strongly recommend you consult an attorney who specializes in trusts and estates and/or a CPA.
